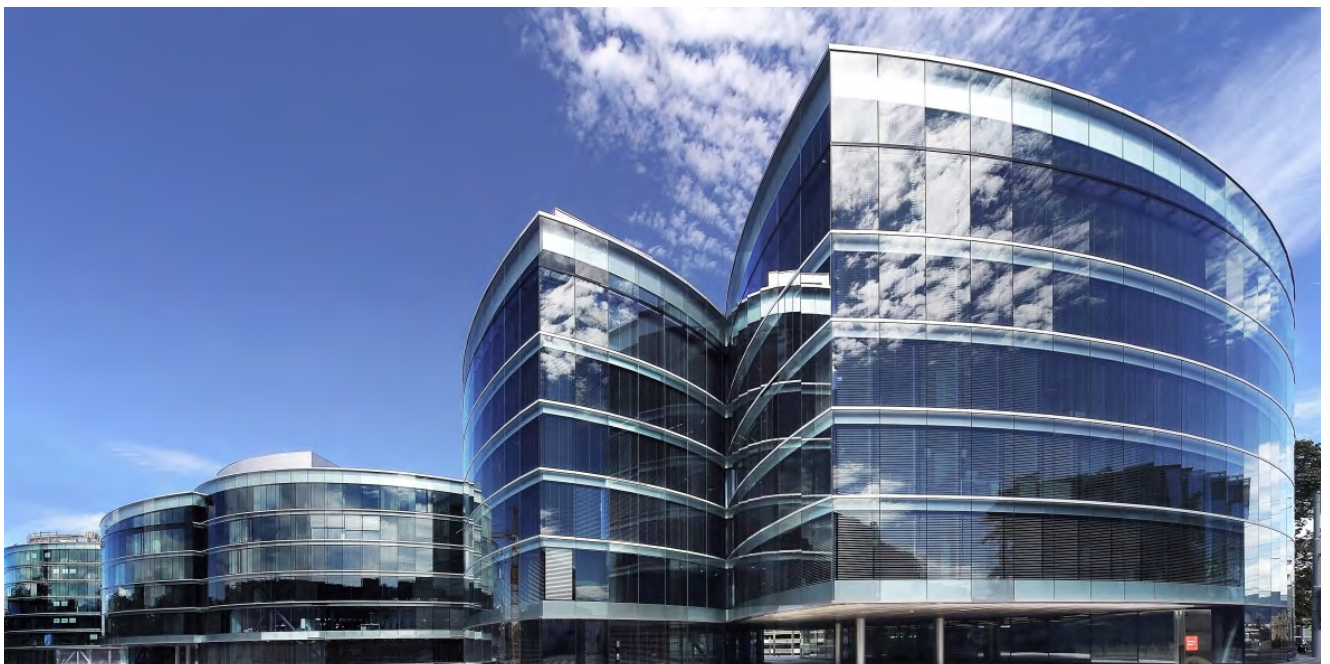
# RESEARCH

In 2023, the GHC hosted 7 research projects:

- New business models for innovation and access to medicines;
- The impact of financialisation on global health: A series of pharmaceutical case studies;
- The Governing Pandemics Initiative;
- The Digital Health and Rights Project (DHRP).
- The *Lancet* & Financial Times Commission on Governing Health Futures 2030: Growing up in a digital world (GHFutures2030);
- The Impact of Social Health Insurance on the Incentives of Health Care Providers in East Africa: A Mixed-methods Approach;
- An Empirical Science of the Spirit: (Near-) Death and Postmaterialist Science in Japan, Switzerland and North-America.

And the GHC also welcomed three Visiting Fellows: Amitabha Sarkar, Naomi Burke-Shyne and Luana Bermudez.

The Centre successfully received four research grant approvals during the year. The following pages provide an overview of each research project and highlight their major accomplishments and publications for 2023.



# NEW BUSINESS MODELS FOR INNOVATION AND ACCESS TO MEDICINES

The objective of this project is to deepen understanding of the political, economic, scientific and organisational factors required to implement new models of medicines R&D that will deliver both innovation and globally accessible medicines. The project investigates the characterisation, history and scope of “alternative innovation models”, and identifies what led to their creation as alternatives to the status quo. The project also identifies the factors that shape whether or not such models survive – or even thrive – within the system, and examine the possibilities they can expand beyond their particular niches. As the project entered its last year, it has started to consolidate its findings.

The project has developed conceptual frameworks to define and draw distinctions between traditional and alternative innovation models, and how they emerge within a complex, adaptive innovation system. Through a mapping of existing examples of alternative innovation models and a series of three case studies, the project assessed across four different areas (i.e., rare diseases, antimicrobial resistance, pandemic preparedness and neglected diseases) the feasibility and effectiveness of these models, exploring impact, structural strengths and weaknesses, and implications regarding who does or does not benefit from each model.

The project has a global scope, including not only initiatives based in traditional centres of pharmaceutical innovation but also initiatives in the Global South, assessing the extent to which such initiatives represent alternative approaches to R&D, and the implications for global access. To assess this, in 2021, the project expanded to include a research collaboration with James P. Grant School of Public Health at BRAC University (Bangladesh) and Universidad de los Andes (ANDES, Colombia). This research collaboration was supported by the Open Society University Network (OSUN) / Open Society Foundations (OSF). Furthermore, since 2020, the project incorporated the study of COVID-19 vaccine innovation models into its work, with a focus on COVID-19 vaccine innovation models in countries like China or Russia.

## Major accomplishments in 2023:

- In February, project team members Adrián Alonso Ruiz and Suerie Moon co-signed a comment on incentives for antibiotic R&D in Europe published in *The Lancet*.
- On Rare Disease Day (28 February), the project team published a review focusing on pharmaceutical policy and innovation for rare diseases. This review was later revised and published in November 2023.
- On 5 April, the project team published the report “**Rising pharmaceutical innovation in the Global South: painting with new colors**” which is part of the “Research Collaboration on Technology,

Equity, and the Right to Health” with BRAC University (Bangladesh) and Universidad de los Andes (Colombia).

- The project team later presented the findings of the three academic institutions during a public hybrid event on 13 April 2023. This research dissemination event was organised through the Centre’s International Geneva Global Health Platform (see chapter “Convening”) and supported by OSF and the Swiss National Science Foundation (SNSF).
- In June, the project team published a database of initiatives that fund, implement or facilitate pharmaceutical R&D in a manner that differs from the traditional business model. The database and the data collection process were both made publicly available on the Knowledge Portal.
- Since June, project team members have been conducting a series of three case studies, doing field visits in Spain and South Korea. The results of the three case studies will be submitted to academic journals by March 2024.
- Between 31 August and 3 November 2023, the project team organised a series of workshops with experts on the four areas assessed by the project (rare diseases, antimicrobial resistance,

pandemic preparedness and neglected diseases) with over 50 participants. The purpose of the workshops was to share the project’s interim results and request feedback to strengthen our findings.

- In September, the project team published on the Knowledge Portal a page dedicated to the “Rising pharmaceutical innovation in the Global South” study. The page features the three reports produced through the collaboration with BRAC University and Universidad de los Andes, the full recording of the April dissemination event, teaching materials (videos, presentations, list of readings) and quizzes.
- On 4 December, Adrián Alonso Ruiz presented some findings of the project at **the Centre’s Research Café** on the theme “COVID-19 Vaccine Development: Unveiling Multiple Business Models and Their Impact on Global Access” (see chapter “Research Cafés”).
- On 19 December, the New York Times published **a story** about leishmaniasis in Colombia, and featured the “Rising pharmaceutical innovation in the Global South” report the project team had published in April.

# THE IMPACT OF FINANCIALISATION ON GLOBAL HEALTH: A SERIES OF PHARMACEUTICAL CASE STUDIES (FINPHARM)

The central objective of this research is to examine the impact of financialisation on the development and use of pharmaceuticals in five areas of global health significance:

- “recycling” of antiretroviral drugs for HIV prevention;
- search for effective treatments and a vaccine for Ebola Virus Disease;
- development of solutions for the threat of antimicrobial resistance;
- use of novel development platforms for COVID-19 vaccines;
- development of monoclonal antibodies for multiple indications.

This research requires an innovative inter-disciplinary approach that brings together expertise in understanding how the worlds of finance and pharmaceuticals work and interact, with insight into how global health problems and solutions then play out in the real world.

Specifically, in each of these areas, we examine how financial motives, markets, actors, and institutions exert influence on the pharmaceutical lifecycle, including through interactions with: “innovation hubs” consisting of research universities and biotechnology companies, wherein public sector resources are leveraged to “de-risk” capital investments in drug discovery; the pharmaceutical industry, in which firms shift strategies to commercialise drugs in different therapeutic areas; and health systems, where governments and health organisations craft public and private mechanisms to pay for medications, especially in response to local health demands.

## Major accomplishments in 2023:

This year was a year of consolidation of the team’s financialisation data sets and collaboration with academics and practitioners in sharing their methodological findings and creating community in preparation for case study completion in the final year of the project. The project team was involved in a number of academic meetings and convened knowledge transfer events including a community of academic, practitioner and policy maker audiences.

### Academic Events:

- On 6 March, the FINPHARM team hosted collaborators from the Empty Pipeline DryAp project from University College Dublin, Ireland at a workshop in Geneva on “Financial Analysis Methods in the Antibiotic Pipeline” to share their expertise on analysing antibiotic development case studies.
- On 8 May, Nadya Wells presented the methodological aspects of her research on Antibiotic Drug Shortages at a **Global Health Centre Research Café** on the theme “Using financial analysis to unpack drug development trajectories” (see chapter “Research Cafés”).
- In June Dena Kirpalani and Nadya Wells received scholarships to join the **Pandemics, Markets and Power doctoral seminar** organised by the University of Oslo exploring how markets shape pandemic prevention, preparedness and response, interacting with researchers from around the world who gathered to share work on the impacts of financialisation in Global Health and Health Security.



- On 10 October, Nadya Wells presented on the subject of "Pénurie globale des vaccins et médicaments: causes et conséquences" to clinical staff organised by the Hôpitaux Universitaires de Genève and Unisanté, Lausanne as part of the **Journée Romande de médecine des voyages** sharing findings from their work on vaccine platforms and antibiotic shortages.
- On 16 October, Dena Kirpalani presented an overview of her research on "Financialisation and the pharmaceutical industry: what's law got to do with it" at a **Global Health Centre's Research Café** (see related chapter).

## Knowledge Transfer Events:

- On 5 July, Nadya Wells was invited to participate in a panel discussion at the **Biorisks, Biosecurity and Biological Disarmament Conference** organised by the United Nations Institute for Disarmament Research (UNIDIR) highlighting FINPHARM work on vaccine platforms and access to antibiotics.
- On 5 October, during the annual "**Building Bridges**" forum, Nadya Wells spoke at a panel discussion on the theme "**Global Health Impact Investment Ecosystem**". The event was co-sponsored by the Global Health Security Fund, Health Innovation Exchange, Gavi, the Geneva Graduate Institute and the World Economic Forum.
- On 11 October, through the Centre's International Geneva Global Health Platform (see chapter "Convening") and in partnership with the Geneva Trade Platform and the World Economic Forum, Nadya Wells held a public hybrid event on the theme "**Global Health Challenges: Can investors and civil society work together?**". The event aimed to initiate a community of practice for long-term engagement between these stakeholders and provide an opportunity to create new forms of collaboration. Thanks to the Platform's media partnership, the event was featured in Health Policy Watch with the publication of the article "**Getting Global Health on the Radar of Private Sector Investors and Asset Managers**" (see chapter "GHC in the media").

# THE GOVERNING PANDEMICS INITIATIVE

The COVID-19 pandemic has exposed major weaknesses in the global system for preparedness and response to outbreaks of infectious diseases. The Global Health Centre's **Governing Pandemics Initiative** (GP), launched in 2021, tracks reform efforts to address these gaps. To do so, the Initiative carries out activities in three main areas:

- **Information, data collection and open-access data-sharing** through a publicly-available website providing ongoing monitoring of reforms;
- **Research and analysis** by developing and making accessible legal and policy research & analysis on key issues, responding to needs that arise as reform efforts progress;
- **Strategic convening** to raise awareness and strengthen capacities by providing a space for discussion, learning, and debate for negotiators, policy makers, and other stakeholders through workshops, public events, webinars, and courses.

The online portal provides a concise overview of six issue areas where change is needed at the global level to better prepare for and respond to future potential pandemics. For each of these, the site offers key official documents, policy briefs and other documents produced by the Initiative, a selection of academic research and analysis, and regular updates on ongoing policy processes. In addition, the website includes a **Timeline** to track efforts to strengthen global pandemic preparedness and response since March 2020, and the **Governing Pandemics Snapshot**, an in-house publication analysing ongoing negotiations on pandemic prevention, preparedness and response (PPPR) (more details below).

This open-access resource aims to inform a wide range of stakeholders, including governments, international organisations, journalists, civil society organisations, the private sector, academic researchers and students, as well as citizens concerned about building a more equitable and effective global system for preventing and controlling potential pandemics.

The project team actively promotes knowledge sharing by producing several opinion and analytical pieces, policy papers, and guides on frequently asked questions. These publications aim to equip negotiators and other public and private stakeholders with the data, analysis, and evidence necessary to make well-informed decisions.

The Governing Pandemics Initiative regularly organises both public events and closed-door workshops and seminars. These gatherings serve as vital forums for engaging with key stakeholders, offering a neutral platform for discussions, and assisting policymakers in their decision-making processes.

## Major accomplishments in 2023:

In 2023, the Governing Pandemics Initiative organised **ten events** and produced and disseminated **seven publications**.

### a. Events:

Throughout the reporting period, our team actively organised a variety of activities and events to facilitate dialogue on ongoing PPPR reforms. These activities encompassed both public events, catering to diplomats, global health practitioners, and our student community, and closed-door sessions tailored specifically for the Geneva-based diplomatic community and government representatives.

On 5 September 2023, the team hosted an inaugural "*Informal, Informal Reception*" at the occasion of the 4-6 September meeting of the Intergovernmental Negotiating Body (INB) drafting group. Following this, a second reception occurred in November alongside the 7<sup>th</sup> meeting of the INB. The idea for organising this type of event stemmed from a suggestion made by several delegations who expressed their disappointment with the lack of a designated space for delegates to gather informally and exchange ideas after negotiation sessions. Over time, these receptions have become a cherished tradition, valued by participants for providing informal networking opportunities and dialogue among key stakeholders engaged in negotiations for the Pandemic Accord and amendments to the International Health Regulations (IHR). The diverse attendance highlights our collaborative efforts and commitment to fostering cooperation for enhanced global health outcomes.

## b. GP 101 Latin America:

Following the successful launch of the free, open, online **Governing Pandemics 101 course** in 2022, this year the GP team partnered with the University of Los Andes (ANDES, Colombia), to launch the Latin America edition of the course. The course was held in Spanish. In this effort, ANDES adapted the 2022 course to address the unique challenges and dynamics of the Latin American region.

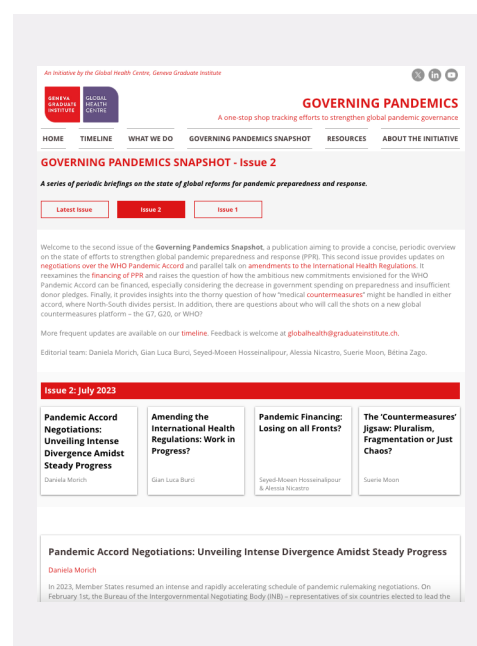
The course provided participants with an opportunity to broaden their knowledge, engage in critical debates, and grasp global governance strategies for pandemic response, featuring insights from Latin American experts. It spanned eight sessions over eight weeks, running from 4 July to 22 August 2023. The programme was tailored for a diverse audience, including policymakers, civil society advocates, government officials, students, healthcare professionals, and journalists.

Each week, the course featured two pre-recorded sessions, including translated content from the original course and newly recorded sessions with regional experts. These sessions were followed by one-hour live discussions, which allowed participants to interact, discuss, and seek clarifications. ## c. Publications:

In 2023, the GP team launched the inaugural edition of a new publication, the **Governing Pandemics Snapshot**. This publication is dedicated to offering concise and periodic insights into the ongoing efforts to reform global PPPR. The first edition made its debut in early 2023, followed by the second edition in July 2023. Each issue consistently delves into three core topics: the ongoing negotiations surrounding a Pandemic Accord, the amendments to the IHR, and financing mechanisms for PPPR.

Furthermore, in every edition, the Snapshot features a rotating special topic. In the first edition, the team discussed Pathogen and Benefit Sharing. In the second edition, the team provided insights on the intricate issue of managing "medical countermeasures" within these instruments, particularly in the context of enduring North-South disparities. Selected articles from the Governing Pandemic Snapshot were also featured on Health Policy Watch, a recognised digital platform for practitioners focusing on global health policy (see chapter "The GHC in the media").



As part of the organisation of the events listed above, the Governing Pandemics Initiative produced a number of discussion papers and workshop reports, all made available through the Initiative's website [resource section](#) (see list below).

In March 2023, upon the release of an updated version of the pandemic accord text, the project team also produced and [published a Thematic Text Comparison](#). This thorough analysis juxtaposed the "Zero Draft of the WHO CA+" with proposed amendments to the IHR (2005). Subsequently, to track changes in subsequent iterations, [another Thematic Text Comparison](#) was released in October 2023. This comparison focused on scrutinising the Bureau's text of the WHO CA+ alongside the Negotiating Text of the WHO Pandemic Agreement. These comparative texts are appreciated by negotiators, as they enable them to study new negotiating texts and their evolution during the negotiation process.

# DIGITAL HEALTH AND RIGHTS PROJECT (DHRP)

The **Digital Health and Rights Project** (DHRP) is a consortium of anthropologists, human rights lawyers, and global networks of civil society activists and affected communities, who are working together in a participatory action research approach that combines ethnographic research, reflection, analysis and policy engagement to:

- use ethnographic field research to develop case studies of youth engagement with digital technologies to address HIV, COVID-19 and sexual and reproductive health in Kenya, Ghana, Vietnam, Bangladesh and Colombia;
- assess what legal and policy frameworks are used to implement these tools, how they are governed, how human rights concerns are addressed, and how integrated youth and civil society are in decision-making for these tools;
- develop a set of global health policy recommendations grounded in human rights principles and legal and ethnographic research, and in the lived experience of affected communities;
- empower transnational youth activist networks with the knowledge, networks and opportunities to raise the recommendations in health policy in national and global health governance; and
- collaborate with UN partners to promote rights-based digital health.

In June 2023, the project fully transitioned to be hosted at the University of Warwick's **Centre of Interdisciplinary Methodologies** (CIM, United Kingdom), and the project's Director Sara L M Davis obtained an affiliation with the Graduate Institute's Global Governance Centre.

# THE *LANCET* & FINANCIAL TIMES COMMISSION ON GOVERNING HEALTH FUTURES 2030: GROWING UP IN A DIGITAL WORLD (GHFutures2030)

Established in October 2021, the joint *The Lancet & Financial Times Commission on Governing health futures 2030: Growing up in a digital world (GHFutures2030)* is exploring the convergence of digital health, artificial intelligence, and other transformative technologies with Universal Health Coverage (UHC) to support attainment of the third Sustainable Development Goal (SDG3). It aims to identify specific instruments to safeguard the rights of children and young people, as well as opportunities to engage in this discussion.

End of June 2023, the Commission left the Global Health Centre and the Geneva Graduate Institute, and transitioned into the Digital Transformations for Health Lab (*DTH-Lab*), a multistakeholder and transdisciplinary lab, to develop cutting edge thinking, sustainable leadership and deliver results for the 2030 SDG deadline.

# AFFILIATED RESEARCHERS AND VISITING FELLOWS

Each year, the Centre welcomes affiliated PhD students and visiting research fellows with research projects involving global health topics and issues, providing an enabling research and working environment in the heart of International Geneva.



Zhubin Chen is a Doctoral Candidate in Development Economics with a minor in Medical Anthropology at the Graduate Institute, and an Affiliate Researcher at the GHC. He is the Principal Investigator of a Doc.ch grant at the Swiss National Science Foundation (SNSF) on the theme "**The Impact of Social Health Insurance on the Incentives of Health Care Providers in East Africa: A Mixed-methods Approach**". His project aims to understand how social health insurance affects the incentives of health care providers and to assess whether it effectively addresses provider incentive problems. Zhubin focuses on social health insurance schemes in three East African countries that have similar economic and demographic characteristics, but distinct health systems. By bridging health economics and medical

anthropology, a mixed-methods approach with an exploratory sequential design is proposed to answer the cross-cutting research questions. In doing so, his project helps fill the literature gap on the impact of social health insurance in low- and middle-income countries, and contributes to a better understanding of social health insurance beyond a means of financial protection from catastrophic health expenditure to a systemic tool to regulate health care delivery.

In March 2023, Zhubin presented his recent field work in Rwanda and preliminary research findings during **one of the Centre's Research Cafés** (see related chapter).

Sam Nelson is a Doctoral Candidate in Anthropology and Sociology at the Graduate Institute, and joined the Centre as an Affiliate Researcher in September 2023. As a recipient of a SNSF Doc.CH grant, he is the Principal Investigator on the project "**An Empirical Science of the Spirit: (Near-) Death and Postmaterialist Science in Japan, Switzerland and North-America**".

Mainstream bioscientific and biomedical models of human conscious experience are dominated by materialist explanations of its production (through the physical processes of the brain) and its limits (at biological death). As such, humans are conceived of scientifically as biological entities whose lives end with the cessation of bodily or cerebral functioning. Contrarily, the emergent discipline of near-death studies (NDS), concerned with explaining the experiences of those who have died and come back to life, offers what Sam refers to as a "postmaterialist" position. Building on literature that reveals death as a sociotechnical phenomenon, as well as a site of moral and political intervention, his research will undertake a multi-sited anthropological analysis of the practices and narratives of postmaterialist NDS, in Japan, Switzerland and North America, to explore how ongoing struggles to understand and define the boundary between life and death are acting as a catalyst for a scientific and political movement from the margins of institutional bioscience.





I was a Visiting Fellow under the aegis of the Swiss Government Excellence Scholarship at the Global Health Centre in the Geneva Graduate Institute from September 2022 to August 2023, and thereafter continued my affiliation as a Fellow with the Centre till December 2023. I offer my profound gratitude to the Centre's leadership for creating exemplary moves to make academic spaces more diverse, inclusive, equitable, and accessible. I am particularly moved by the Centre's deliberation to routinise collective consultation (such as fortnightly huddles) and nurturing the environment of open dialogues. During my tenure, I have had the opportunity to work with colleagues and students from all walks of life.



Their diverse backgrounds, lived experiences, and philosophical reasonings enriched me both intellectually and culturally. I am indeed thankful to my supervisor Professor Suerie Moon, who emphatically supported my visiting tenure at the Centre, and served as a continuous point of guiding light throughout the fellowship. Because of that fellowship, I became a part of important academic networks, fostered multiple policy dialogues, and most importantly academically contributed to the intellectual life of the Centre and the Institute on a number of occasions especially through publications, presentations and teaching. To this end, I had an overwhelming experience while working with the Institute's flagship Applied Research Projects (ARP) as an academic supervisor for the Master students in the Global Health track. Naomi Burke-Shyne is the Executive Director of Harm Reduction International and a GHC Visiting Fellow. She is an expert on harm reduction and drug policy, bringing two decades of international work experience at the intersection of law, HIV, human rights and public health.

In 2023, Naomi undertook research and analysis on funding flows for health, focusing on harm reduction, HIV and viral hepatitis; with a view to identifying sustainable solutions for critical health services. Naomi joined forces with health practitioners to publish commentaries on the funding landscape for hepatitis (*The Lancet Gastroenterology and Hepatology*), on international development funding and drug control (Devex), and on gender and equity in the Pandemic Accord (*The Lancet*). Naomi moderated dialogues within the global hepatitis community and delivered a plenary address on the funding landscape at the 11<sup>th</sup> International Conference on Health and Hepatitis in Substance Users.

Luana Bermudez was a Junior Visiting Fellow at the GHC until end of June 2023. # CONVENING

## INTERNATIONAL GENEVA GLOBAL HEALTH PLATFORM

Throughout the years, the Centre has positioned its activities within the context of International Geneva with the aim of strengthening the city as the “global health capital”. In this context, the GHC signed a multi-year contract with the Swiss Federal Department of Foreign Affairs (FDFA) to strengthen Geneva as a hub of global health. Through its **International Geneva Global Health Platform** (the Platform), the Centre engages with a wide-range of institutions and acts as a laboratory of global health innovation. From 2014 to 2023, the Platform has encouraged a vast number of global health actors to work together on topics of common concern, and built cross-sectoral synergies. The Platform has established itself as a host for policy dialogues, roundtables, research seminars and other public and closed-door events.

### Convening:

In 2023, the Platform co-organised **23 events**, of which 14 were public – hybrid or online – panel discussions, and nine were closed-door workshops (see chapter “The Governing Pandemics Initiative”). The Platform also co-sponsored a number of external events organised by Global Health organisations and partners.

In May during the World Health Organization (WHO)'s 76<sup>th</sup> World Health Assembly (WHA), the Platform organised a new edition of the **Geneva Health Week** as follows:

- the Open Briefing, in partnership with the United Nations Foundation, which attracted more than **300 participants** in the Graduate Institute auditorium, while being livestreamed on YouTube;
- four side events, co-organised with a number of partners, which attracted a total of more than **800 in-person and online participants**.

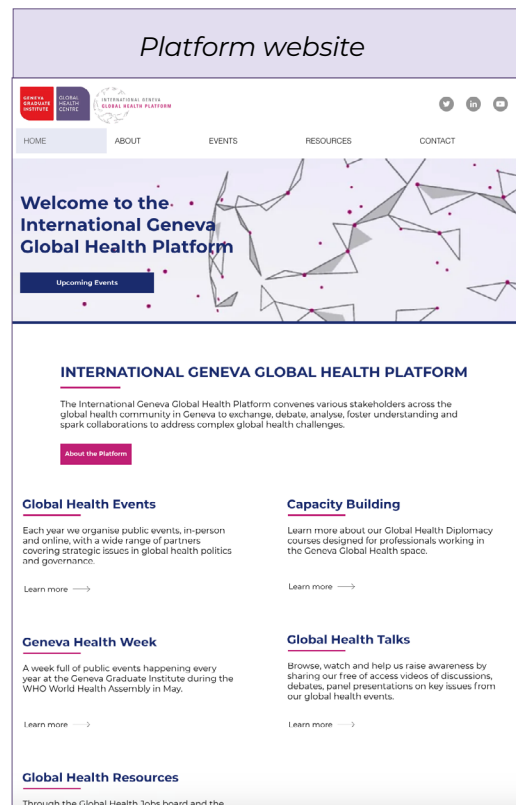
The Platform also co-sponsored two major external events:

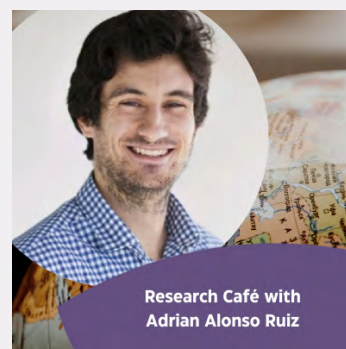
# CONVENING RESEARCH CAFÉS

In 2023, the Global Health Centre decided to re-launch its research seminars under a new format: **the Research Cafés**. Providing an opportunity for GHC Researchers and Fellows to present their work, these one-hour, lunch-time gatherings enabled them to share advancements and findings, and to exchange ideas with the Centre's community, including staff members, Graduate Institute students and the external public.

Across the 2023 Spring and Fall semesters, the Centre organised six Research Cafés on the following themes:

- "**Community-Based Health Insurance in Rwanda: Organisation, Payment, and Practice**" presented by Affiliate Researcher Zhubin Chen;
- "**Using financial analysis to unpack drug development trajectories**" presented by Senior Research Adviser Nadya Wells;
- "**Access to COVID-19 Vaccines in Latin America**" presented by Junior Visiting Fellow Luana Bermudez;
- "**Financialisation of the Pharmaceutical Industry: What's law got to do with it?**" presented by PhD Candidate and Research Assistant Dena Kirpalani;
- "**Reimagining the future of Global Health Initiatives**" presented by Dr. Rosemary James;
- "**COVID-19 Vaccine Development: Unveiling Multiple Business Models and Their Impact on Global Access**" presented by Research and Project Manager Adrián Alonso Ruiz.

The Research Cafés were attended by a total of **97 participants** out of **107 registrations**, highlighting an exceptional **attendance rate of 91%** and the demand by the local Global Health community for more research oriented gatherings and discussions.



# THE GHC IN THE MEDIA

In 2023, the GHC continued its collaboration with Health Policy Watch, a digital media outlet active in the global health field. The partnership developed with Health Policy Watch aims to diversify and expand the GHC audience groups, boost the number of event participants and courses applications, and increase our geographic reach. The event stories produced by Health Policy Watch captured the main points addressed by speakers, highlighted key takeaways, and helped to raise awareness on specific global health issues.

This partnership also included editorial, publication and promotional support from Health Policy Watch on the two editions of the Governing Pandemics Snapshot produced by the Governing Pandemics team (see related chapter).

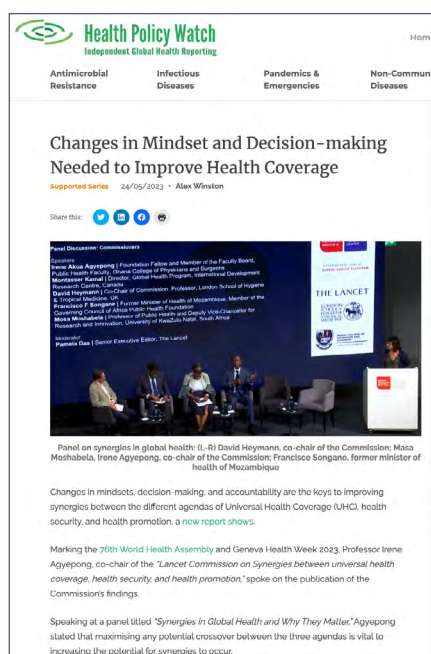

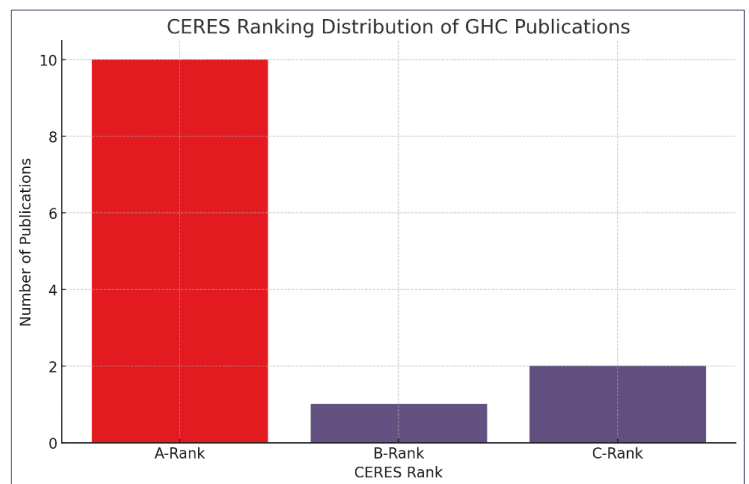
# GHC PUBLICATIONS

This chapter presents an evaluation of the GHC's academic contributions over the past year, emphasising the quality, reach, and impact of scholarly publications from research projects and team members. Through Monitoring and Evaluation (M&E) processes, including CERES rankings, and Altmetric and PlumX attention scores, we assess the influence and recognition the Centre's research has garnered within the academic community and beyond. This analysis not only highlights the Centre's commitment to producing **high-quality research** but also underscores its dedication to **open access** and **policy engagement**, reflecting the Centre's ongoing efforts to advance global health knowledge and practice.

## CERES Ranking

CERES Ranking evaluates the quality of academic journals and publishers. The GHC uses this system for quality assurance and to boost the visibility and recognition of its research.

Among 13 peer-reviewed GHC academic publications, including peer-reviewed articles, commentaries, and book chapters, **ten achieved the highest quality (A-Rank)**<sup>1</sup>, one was recognised with high quality (B-Rank)<sup>2</sup>, and two were deemed good quality (C-Rank)<sup>3</sup>.

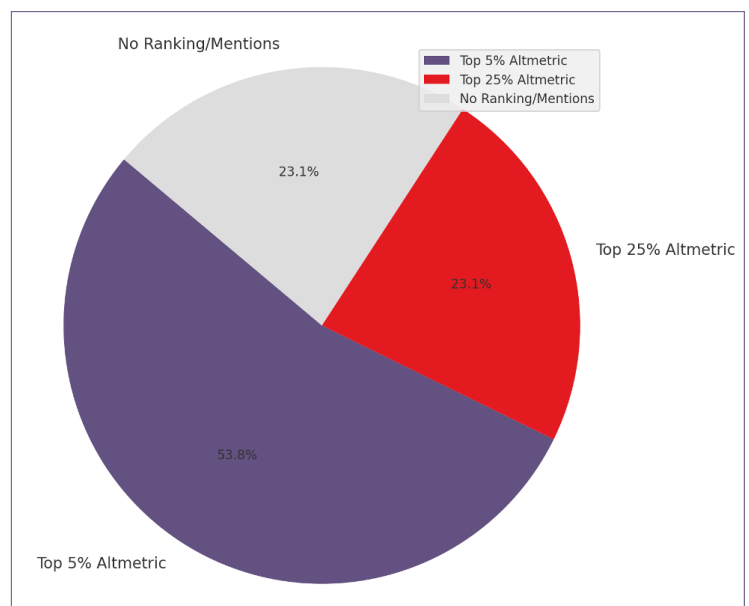


## Attention scores

The attention scores from Altmetric and PlumX reflect the online visibility and impact of a publication within its first year. These scores measure both the quality and reach of the Centre's work, based on online discussions up until 13 January 2024.

Here is an overview of the GHC articles' scores:

- **seven publications reached the top 5%** of all research outputs ever tracked by Altmetric;
- **three publications reached the top 25%** of all research outputs ever tracked by Altmetric;
- And three publications have either no available ranking online or there were no mentions (too early to measure or attracted low interest).

Two out of the seven top 5% publications stand out either due to the news coverage they received or their impact on global policy-making discussions:

- The commentary "*Antimicrobial resistance and the Iraq wars: armed conflict as an underinvestigated pathway with growing significance*", co-authored by GHC Co-Director Vinh-Kim Nguyen and by GHC team member Anthony Rizk, published in February 2023 by BMJ Global Health, gathered a widespread media interest, appearing in 29 news stories across 26 outlets, including **EL PAÍS**, **The Conversation** and STAT News. - In our analysis, only two *Lancet* publications were assessed using PlumX metrics. Notably, the commentary "*Transferable exclusivity voucher: a flawed incentive to stimulate antibiotic innovation*", co-authored by GHC Co-Director Suerie Moon and GHC Research and Project Manager Adrián Alonso Ruiz, published in February 2023 by *The Lancet*, **received significant policy attention**. It was cited in 12 policy documents, including influential ones from the European Parliament and the Council of Canadian Academies.
